**Admission:**

1-day General Admission \$5.00 for Adults, children under 12 are free when accompanied by a paying adult.

**Set Up:**

Set up will begin at **8:00am Thursday, October 11<sup>th</sup>**

- Booth/Tent vendors set up after 12:00/Noon Thursday, or by 9:00am opening day.
- Land Bulk space vendors set up 8:00am-5pm Thursday
- In-Water vendors must load-in before sunset Thursday

**Exhibits:**

- Booth and Land Bulk spaces are displayed on asphalt
- Electric and water is **NOT** available
- In-Water vendors may **NOT** drill into or damage the docks in any way. Flags and banners can be temporarily displayed for the show.
- Demos are **NOT** available to in-water vendors

**Appearance:**

Exhibitors are strongly encouraged to carpet their displays and skirt their tables to improve the overall appearance of the show.

**Breakdown:**

Booth exhibit and In-Water exhibit breakdown can begin immediately after the show closes Sunday at 5:00 p.m. On-Land bulk exhibit breakdown can begin

8:00am Monday, October 15<sup>th</sup>. **All products must be cleared from the site by Monday 5:00pm. Failure to do so will result in a per day fine. If product is not removed, you will be billed for the fines incurred. THERE ARE NO EXCEPTIONS.**

**Booth/Tents** All booths will be provided by show management and will measure 10' x 10' and come equipped with tent, sidewalls, 6' folding table, and 2 folding chairs. **Electric and water is NOT provided.**

**Security:** Private security will be provided after hours beginning Thursday, October 11<sup>th</sup> through Monday, October 15<sup>th</sup>

**Tents/Fire Compliance:** **All exhibitor tents NOT ordered through Show Management, must be erected by Thursday 3 p.m., October 11<sup>th</sup>. A pre-inspection for fire regulation compliance will take place that afternoon. If your tent is not finished by 3:00pm for inspection, you will be removing it and will be unable to use it in the show. All tents must be securely anchored with a 25lb ballast to each pole. A PVC pipe filled with cement or sand is preferred.**

**Food:** Concessions, non-alcoholic beverages, beer, wine and liquor will be available for purchase on show grounds.
