Food Vendor Fees (including Food Trucks and trailers): \$100/day or \$350 for the entire 4-day event. Application and fee must be received by no later than Friday, January 3, 2020. No refunds will be made for cancellations within 60 days of the event, no shows, or inclement weather. **NO EXCEPTIONS.** There are no rain dates. The event will be held rain or shine. We highly encourage imaginative booth designs, flags, props/costumes, etc to be used in your space.

Included Items:

10'x10' area with approximately 5' behind the tent for smokers/grills
Food Trucks receive a custom spot up to 40' wide
5 Vendor wristbands for booth staff

Proceeds: Food trucks and vendors keep 100% of their proceeds for sales on the days of the event. However, food trucks/vendors are not allowed to sell **ANY** beverages at the event (alcoholic or non-alcoholic) unless approved by show management.

Set-up, Hours, Breakdown: Food Trucks/Vendors may begin to arrive as early as 11 a.m. on Wednesday, January 15, or at 8am on assigned event day. All set-up must be completed no later than 2:00p.m. on Wednesday for Fire Marshall walk through or by 9am for assigned event day. All food trucks/vendors are required to remain open until 5p.m. on event days. There will be **NO** teardown prior to 5p.m. Private security will be on site throughout the event.

Food Truck/Vendor Application Acceptance Policy

Confirmation for the Naples Boat Show is based on the date and time of application submissions AND payment. Additionally, we will take your menu into account when we receive your completed application as our goal is to bring local food vendors/food trucks to the forefront to provide a unique experience for attendees by ensuring variety. While we are unable to guarantee there will not be competing vendors, we will take this into consideration as we receive vendor applications. The Naples Boat Show reserves the right to turn down applications (and return fees) based on the number of applications received and overall variety of applications.

All food trucks and vendors must be able to operate independently of any provided resources including water, electrical, refrigeration and any materials. Vendors are responsible for all set-up and clean-up of their booth space and their immediate area surrounding such space.

Show management will provide trash containers, eating areas, tables/chairs, restroom facilities and ATM. **The trash containers provided on show grounds are for the attendees, do not stuff those containers with boxes or other large items.**

If you are using your own tent, it must be fire retardant and professionally branded (any color is ok) with your company's name and/or logos or be SOLID WHITE. Tents **MUST use weights (sand bags, concrete buckets, water jugs, etc) with 25 lbs per leg minimum.** This is strictly enforced by the Fire Marshall! A tent can be rented with install/teardown by our event company using the attached exposition form if necessary.

If you are using your own generator it **MUST** be in perfect working condition and be an Ultra Quiet branded generator or you will not be allowed to use it.

Vendors using grease/oil fryers are required to have some form of cardboard ground covering underneath the equipment to prevent stains/spills on the show grounds. Vendors are also responsible for the proper removal of said grease/oil at the end of the event. Absolutely **NO** pouring grease onto the grass on show grounds allowed. **Food Vendors MUST have a working ABS fire extinguisher in their booth!**

All trucks/trailers that have grease laden vapors **MUST HAVE** a working ansul system installed.

Insurance Information

All food vendors must have insurance certificates into the MIACC office no later than **January 3, 2020**. Certificates must indemnify and agree to defend the following **with minimum liability of \$2,000,000**
