

This is a training course for marine contractors to learn to install living shorelines for property owners, either alone or in addition to an existing seawall or other structure. Living Shorelines are softer, greener alternatives to stabilize shorelines from erosion, sea level rise, and other damage. They protect, restore, or enhance natural shoreline habitat and maintain coastal processes through the strategic placement of plants, oyster shell, and other structural organic materials. Demand for these structures is increasing, and this course offers a mechanism to increase the supply of contractors who can fill this need.

Six hours of Continuing Education Units will be offered to contractors through the Construction Industry Licensing Board. CEUs are contingent upon completion of the full course and the final exam on day 2.



The course will run from 8:30 a.m. to 4:30 p.m. each day and will include 2 field trips. Please wear or bring clothing and shoes suitable for outdoor site visits in coastal areas. We will not be getting in the water, but participants will be conducting site assessments and follow-up evaluations for living shorelines.

You may want to bring sunglasses, hat, sunscreen, and a reusable water bottle.

The classroom is on the third floor of the NOAA facility. You may park in the parking lot in front of the building, preferably on the third and fourth rows. The gate to the parking lot will raise automatically as you approach it. Please arrive 15 minutes early and wait in the lobby of the building to be escorted in group(s) to the third floor. You may tell the security guard that you are here for Tampa Bay Estuary Program.

Coffee and light snacks will be provided, and lunch is on your own from 11:45 a.m. to 1:00 p.m. Field trips will take place immediately after lunch, so you may choose to eat near the classroom or the field site. You will be given one hour and 15 minutes total to eat lunch and travel to the field site.

All learning materials will be provided, including a course workbook, so you only need to bring your identification to the course.


